# Treasurer's Report:

From Danny W's Treasurer's Report, submitted:

During April, deposits totaled \$1012.00 and disbursements amounted to \$3235.21. 50/50 raffle income for February and March totaled \$70; Camping & Food cash donations from Borrego Springs event was \$100, and for El Capitan it was \$287; renewing and new memberships amounted to \$75. The Mt. Laguna event deposits totaled \$480. Four checks were issued: \$2900 for the final deposit to Laguna Mountain (Lodge), \$27 for memberships pins, \$82 to the Postmaster for the PO Box rental, and \$226.21 for El Capitan food related reimbursements. The Operating Fund ending balance is \$6249.74 and there remains \$3179.56 in the Rally Fund.

Danny also reviewed the Reconciliations and Profit/Loss details.

These reports were approved.

Tom White was not present, as he is out of town, but the Mileage Contest is up to date.

#### **Newsletter Report:**

Erasmo Brenes has put out the May Newsletter. Well done from the Board.
